### Orcas Choral Society Health Protection Pledge for the 2025-26 Season

### I agree to:

- Avoid rehearsals if I am sick, especially with a respiratory ailment.
- Quarantine if I test positive for COVID-19.
- Before I return to rehearsals after testing positive for COVID-19, I will take an at-home antigen COVID-19 test to make sure I'm no longer contagious.
- Inform my Section Leader and Membership Chair (Faith Heath) if I am unable to attend rehearsal.
- Inform my Section Leader and Membership Chair if I have tested positive for COVID-19 and may have been contagious during a rehearsal. (Orcas Choral Society will then inform all members of a potential exposure.)
- I will cover any cough or sneeze during rehearsal and excuse myself and leave the room if I keep coughing/sneezing.
- I understand that Orcas Choral Society will continuously monitor local and government health alerts and increase health protection measures if there is a surge of COVID-19 or other respiratory disease on Orcas during the 2025-26 season.

Participation is for the entire season (September through May) whenever possible. High School students are welcome at the Artistic Director's discretion. Any extended absence must be discussed with the Artistic Director and your Section Leader AND let Faith Heath (<u>faithjohn@gmail.com</u>) know in advance.
